4. TERMS OF CONTRACT

a) Selected candidates shall be appointed on purely contractual basis for the maximum period of one year or till the joining of regular faculty whichever is earlier.

b) The Contractual engagement may be terminated / discontinued on either side giving one-month prior notice to this effect without assigning any reason.

c) Other terms and condition will be applicable as issued by competent authority from time to time.

d) This being 01 Year contract, absence for period beyond 15 days will be treated as abandonment of duty and the contract will be terminated without any reason and security deposit will be forfeited.
