

Indian Council of Forestry Research and Education (ICFRE), an autonomous body of the Ministry of Environment and Forests, Govt. of India, invites application from amongst the eligible officers under Central Government/ State Government/ Public Sector undertakings/ Autonomous bodies/ Statutory organizations for filling up one post of Financial Advisor on deputation including short term contract at ICFRE Hqrs., Dehradun in the Pay Scale at Level 13 of Pay Matrix plus usual allowances as admissible under rules in ICFRE.

# (A) Eligibility:

An Indian Audit and Accounts service officer having 13 years experience with respect to year of allotment OR an officer of sub-ordinate accounts service under Government of India having 16 years experience, including at least 10 years in the Pay Band-3: Rs.15,600-39,100/- + G.P. Rs.6,600/-p.m. (pre-revised).

# (B) Tenure:-

The tenure shall ordinarily be 3 years or ill superannuation, whichever is earlier. The tenure is, however, liable to be terminable at an earlier date or extendable at the discretion of appointing authority/cadre controlling authority.
