- 3. Selection Procedure:

5. Call letter for interview:

Call letter for interview and any other communication will be sent to the eligible candidates at the E-mail address given in their application form and to the address by ordinary post only.

6. Action against candidates found guilty of misconduct:

Candidates are instructed that they should not furnish any particulars that are false, tampered/ fabricated or suppress any material information while filling up the application form and submitting the attested copies of certificates. If found guilty, their candidature is liable to be rejected/ contract terminated without any notice.

  - d) Candidates are required to paste one recent passport size photograph in the space provided for in the application format and sign it across.
