- 12.2 For candidates belonging to OBC category, the category certificate should be in the prescribed format including the Non-Creamy layer Clause issued by the Competent Authority for employment under Government of India and should be as per the Central list of OBC's published by the Govt. of India. Please also note that the validity of Non-Creamy layer Certificate should not be older than 6(six) months from the date of eligibility criteria.
- 12.3 Applicants working in Government/Semi-Government/Public Sector Undertakings or autonomous bodies, must come with the complete Application Form routed through proper channel or along with No Objection Certificate from their present Employer.
