5. Rural, Ex-servicemen, Displaced from Projects Certificates (if claimed).
6. 3 Character Certificates (1 from Institution and 2 from Respectable Persons)
7. No Objection Certificate from the Employer (for In-service candidates).

Note: Candidates who fail to produce the **ORIGINAL CERTIFICATES/ DOCUMENTS** on the date of viva-voce are liable to be disqualified.
