- 4 Applications without photograph, signature and necessary Marks cards, certificates in support of their application shall be summarily rejected.

- 6 The prescribed Essential Qualifications are a bare minimum and mere possession of it, will not entitle the candidates to be considered for the post. The candidates should furnish all the Qualifications and Experience possessed in the relevant field, over and above the minimum qualifications prescribed
