In pursuance to the Notification dated: 18.07.2019 cited at (Ref-1) recruitment process to fill up vacancies of Sub-Inspector of Police (Civil) (Men & Women) including In-Service was initiated. After the recruitment process this Office published First Provisional Select List for the above post on 20.03.2020. After publishing the First Provisional Select List, candidates selected were subjected for Medical Examination as prescribed in the Cadre and Recruitment Rules called the Karnataka State Police including Ministerial Services (Recruitment) (Amendment) Rules, 2009. After conducting the medical examination, based on the report of the Medical Board, Second Provisional Select List was published on 22.06.2020 (Ref-3). As per the report, in the medical examination Kum. Poojashree M., was declared unfit. Hence, her candidature has rejected and cancelled vide this office order of even number dated: 04.08.2020.

After publishing the Second Provisional Select List, Commissioner of Police, Mangaluru city was directed to verify the character and antecedents and also reservations claimed by the candidates selected in the Provisional Select List. After due verification, reports are sent to this office by the Commissioner of Police, Mangaluru city authorities vide letter cited at (Ref-4).

Due to the revision of list, the selected category of the candidate namely Sri. Jagadeesha (bearing roll No: 3729264) has been changed from SC\_(Others) to SC\_(RUR) as per his merit and reservation. Therefore, he is selected from Mangaluru City to Western Range, Mangaluru. In his place the new candidate i.e., Sri Ashok, is selected as per merit and reservation.

Thus as per C&R Rules, the Final Select List of candidates pertaining to **COP, Mangaluru City** unit in order of merit for the post of Sub-Inspector of Police (Civil) (Men & Women) including In-Service is prepared and it is as under.
