In pursuance to the Notification dated: 18.07.2019 cited at (Ref-1) recruitment process to fill up vacancies of Armed reserve Sub-Inspector (CAR/DAR) (Men) was initiated. After the recruitment process this Office published First Provisional Select List for the above post on 06.07.2020: After publishing the First Provisional Select List, candidates selected were subjected for Medical Examination as prescribed in the Cadre and Recruitment Rules called the Karnataka State Police including Ministerial Services (Recruitment) (Amendment) Rules, 2009. After conducting the medical examination, based on the report of the Medical Board, Second Provisional Select List was published on 07.08.2020(Ref-3).

One candidate who was selected for both the post of Armed Reserve Sub-Inspector (CAR/DAR) (HK) & (NHK) i.e., Sri Mohammad Waheed, bearing Roll No: 3500118 has expressed his unwillingness to join the post of Armed Reserve Sub-Inspector (CAR/DAR) (NHK) as per his affidavit cited at reference-4. Accordingly, considering the request of the candidate his candidature was cancelled vide order No.85/Rect-2/2019-20, dated:07.08.2020.

After this **Inspector General of Police**, **Southern Range**, **Mysuru** was directed to verify the character and antecedents and also reservations claimed by the candidates selected in the Provisional Select List. After due verification, reports are sent to this office by the **Inspector General of Police**, **Southern Range**, **Mysuru** vide letters cited at (Ref-5).
