PROVISIONAL SELECT LIST

1. In pursuance to the Notification dated: 18.07.2019 cited at reference-1, recruitment process to fill up 200 posts of Sub-Inspector of Police (Civil) (NHK) (Men & Women) including Inservice was initiated. After completing the recruitment process as per all the procedures laid down in the Cadre and Recruitment (Amendment) Rules, 2009 & 2016, Provisional Select Lists were published cited at reference-2.
2. Whereas, in the verification report cited at reference 4 & 5. It is found that the criminal case against three candidates i.e., Sri. Anil Shreemant Nayak, Sri. Chidanda M Halladmal and Sri. Pradeep Mahaveer Halaki are registered and the said cases are still pending. Also Sri. Pradeep Mahaveer Halaki it is found to be medically unfit. This being the position, three candidates are not eligible to be considered for selection and appointment as per the conditions stipulated in rule 10 of the general recruitment rules and as per the order dated:01.12.2014 of the Hon'ble Supreme Court of India passed in Civil Appeal No:10613 of 2014. Hence, the candidature and selection of three candidates are rejected and cancelled vide this office order of even number dated:04.08.2020.

3. Whereas, after publishing provisional select list for the above post, selected candidates were subjected to medical examination before a duly constituted medical board. After the medical examination, the report of the medical examination has been sent by the IGP, Central Range, Bengaluru and Commissioner of Police, Mangaluru City. As per the report, in the medical examination Sri. Basappa Mudakappa Walad and Kum. Poojashree M., were declared unfit. Hence, their candidature has rejected and cancelled vide this office order of even number dated:22.06.2020 & 04.08.2020.
4. Due to the cancellation of the candidature of five candidates, five posts in Sub-Inspector of Police (Civil) have remained unfilled. In order to fill up the five posts this Provisional Select List is being published with the following conditions.
- This list is subject to the outcome of the results in the medical examination to be held by a Medical Board constituted as per the rules.
 - The fact that the name of the candidate figures in this list does not give him any legal right for appointment to the post which will be dependent on the aforesaid conditions.
 - This select list is subject to the final decision of the Hon'ble Karnataka State Administrative Tribunal/ Hon'ble High Court of Karnataka / Hon'ble Supreme Court of India.
