- iv. Target oriented proactive claim management and loss assessment activities in the State as per direction of the Company from time to time.
- v. Analysis and reporting of various critical information viz. sowing progress, crop / weather condition or any other information which are integral part of Claim Management.
- vi. Regular reporting of activities to AIC Regional Office / Head Office.
- vii. The job will require extensive travelling within the State.
