Rail Wheel Factory desires to engage Allopathic Medical Practitioners on contract basis to meet the local requirements for handling COVID-19 pandemic for Covid Care Centre at RWF initially for a period upto 31.12.2020, which can be extended as per administrative requirement subject to extension of the scheme against which engaged.

Place of Interview : Office of the Principal Chief Medical Officer, Railway Hospital, Rail Wheel Factory, Yelahanka, Bangalore-560 064.

Date and time of Interview : Interview will held on 07.10.2020 from 11.00 to 13.00 hrs.

Candidates who are interested should come to the above venue with Registration No. and all necessary certificates in original.

Eligibility Criteria/Qualification:

General Duty Medical Practitioner: The candidate should be MBBS and should be in possession of a valid registration certificate of any of the State Medical Council of India after completion of one year compulsory rotatory internship. **Candidates who possess Post Graduate Degree/Diploma in any clinical subjects like Anesthesia, Industrial Medicine/Occupational Health, Radiology, Ophthalmology, etc., are preferred.**

Terms and conditions:

Monthly remuneration: Rs.75000/- per month, fixed. If Government accommodation is provided an amount equivalent to the sum of House Rent Allowance and license fee of the accommodation so provided will be deducted.

Age: Should not have completed more than 50 years as on 01.08.2020.

(a) The engagement of Doctors would be on full time contract basis initially for a period upto 31.12.2020/ till the scheme against which engaged is in existence. Further the services of these Doctors are also terminable before expiry of the above period by either side after giving fifteen days notice or on payment of fifteen days remuneration in lieu of the same. The services rendered as contract doctors is a stop gap arrangement and will not have any bearing in respect of consideration of their period of service in case of regular selection through UPSC. It will also not confer any right for regularization or absorption. **No private practice is allowed.**

(b) The contract doctors shall not be entitled for Railway Quarters, etc., as a matter of right. However, if available they will be provided accommodation. The detailed instructions with regard to their duties while on contract with Railways shall be given to them in the event of their selection alongwith the offer of engagement.

(c) The eligible and willing candidates should report at 11.00 hrs on 07.10.2020 at the Office of **The Principal Chief Medical Officer, Railway Hospital, Rail Wheel Factory, Yelahanka, Bangalore-560064** alongwith application form in the format appended duly enclosing necessary attested copies of the testimonials. Original certificates should be produced for verification.

(d) No TA/DA will be paid to the candidates attending the Interview.

2. Retired Railway doctors upto the age of 65 years may also apply, on fixed remuneration of Rs. 75,000/- per month (subject to the condition that remuneration plus pension drawn by retired Railway doctor will not exceed the last pay drawn). **The details of scheme, terms and conditions as notified in terms of Rly Board's letter No.2008/E(GR)II/1/1 dated 16.07.2012, will be applicable for engagement of retired Railway doctors as Contract Medical Practitioners (CMPs).**
