In pursuance to the Notification dated: 24.10.2019 cited at (Ref-1) recruitment process to fill up vacancies of Sub-Inspector of Police (Civil) (Men & Women) including In-Service was initiated. After the recruitment process this Office published First Provisional Select List for the above post vide cited at reference-2. After publishing the First Provisional Select List, candidates selected were subjected for Medical Examination as prescribed in the Cadre and Recruitment Rules called the Karnataka State Police including Ministerial Services (Recruitment) (Amendment) Rules, 2009. After conducting the medical examination, based on the report of the Medical Board, Second Provisional Select List was published on 05.11.2020(Ref-3). After publishing the Second Provisional Select List, Inspector General of Police, Southern Range, Mysuru was directed to verify the character and antecedents and also reservations claimed by the candidates selected in the Provisional Select List. After due verification, reports have been sent to this office by the Inspector General of Police, Southern Range, Mysuru vide letters cited at (Ref-4). As per the reports, the character and antecedent and document verification have been completed for 13 candidates. Hence, they are eligible for Final Select List. Thus as per C&R Rules, the Final Select List of candidates pertaining to Inspector General of Police, Southern Range, Mysuru unit for the post of Sub-Inspector of Police (Civil) (Men & Women) including In-Service is prepared and it is as under.
