- The documents of the shortlisted candidates will be verified with the originals at the time of joining at OIL.
- Candidates sending the Biodata form without the required scanned documents as mentioned above will be rejected.
- A duly self-attested (with date) recent passport size photograph has to be compulsorily affixed on the top right corner of the application duly self-attested (with date). Applications without photographs will be rejected.
- Experience will be calculated strictly based on the experience certificates provided/sent vide email along with the application form. Candidature of Candidates not providing experience certificates will be rejected
- The candidates shortlisted for the interview will be informed through e-mail about the date and time of interview. As such candidates are advised to mention a valid email ID and mobile no.
- The interviews for the shortlisted candidates will be online. The mode of interview (Google Meet, Zoom Call/ Webex, etc.) will be intimated to the eligible shortlisted candidates well in advance.
- The candidates will be shortlisted for interview after scrutiny of eligibility by OIL. Candidates meeting the eligibility criteria will only be called for the contractual interview.

#### 6.0 Selection Criteria:

- The candidates will be selected based on Online Personal Interview of total 100 marks.
- The minimum qualifying marks will be 50 for all categories.
- The breakup of 100 marks will be on, Professional Knowledge and skills (in concerned discipline), Professional Knowledge and skills (in allied discipline), Personal Attributes and Soft Skills.

# 7.0 Experience Requirement, Job Profile & Responsibilities:

#### I. Drilling Engineer on contract for Rajasthan Field

- Candidates should be able to operate AC/SCR, drilling rigs and workover rigs with knowledge on operation of the rigs and down hole complicacies and be able to take decisions relating to down hole and surface problems in drilling/workover wells, operating draw works & handling of brake.
- Candidates should have knowledge to identify and do the necessary trouble shooting of the rig equipment and tools and have knowledge of HSE & statutory rules & regulations as per Mines Act, OISD rules etc.
- Candidates should be able to detect well control situation and overall management of the well site crew with good inter-disciplinary skills and he/she should be conversant about mud chemicals & maintenance of mud property.
- Candidates must possess a valid Well Control Certificate (IWCF)/Well cap Certificate
- Other things being equal, a candidate having exposure to thermal completion wells shall be given preference
- The selected candidate will function as Company Representative in drilling and work over wells and will be in-charge of well operations.
- The selected candidate will receive and dispatch well consumables/materials at/from well site.
- The selected candidate will send daily progress report regarding all operations at rig site in Company's DPR format.
- The selected candidate will supervise well operations, provide technical guidance and ensure safety in all respects at rig site.
- The selected candidate will hold daily Tool-box meeting, Pit level meeting, Job safety analysis, Fire Drill, BOP Drill etc. as per standard practice.
- The selected candidates will coordinate the activities of all service providers.
- The selected candidate will be responsible to carry out all operations as per the well policy and/or as directed by Company officials designated by HOD.
- The selected candidate will report to Installation Manager/Operation Manager and be guided by him as regards operations and safety related issues.
- The selected candidate will be responsible for maintaining all relevant well records, safety documents and test reports.
- The selected candidates will be responsible for proper functioning of well-site/base camp.
- The selected candidate will be responsible for ensuring compliance of all contractual obligations by the service providers.

## II. IT Engineer on contract for Rajasthan Field

- The selected Candidate will be responsible for Jobs related to IT Network, PC, Printer and other accessory maintenance at Rajasthan Field and as such should have experience of the same.
- The selected candidate will be responsible for Jobs related to data and voice communication at the remote operational areas at Tanot, Dandewala, Baghewala etc.
- The selected candidate will be responsible for jobs related to Security Access Control System (CCTV, VMS, Biometric attendance, etc.) at Rajasthan Field.

### III. Chemist on contract for Drilling Operations in Rajasthan Field

- The candidate should have skills to perform during critical conditions like pipe stuck, mud loss, well inflow, etc.
- The candidate should be able to perform laboratory testing to ascertain the performance of drilling fluid.
- Managerial skills to control the key factors of mud engineering, optimal use of proper chemicals, maintaining stock position considering logistics and other factors of Rajasthan.
- The selected candidate will be posted in Rajasthan and work as well-site Chemist as per requirement.
- Completely responsible for chemical activities inside the well-site.
- Attending and rectifying down hole problems.
- Report generation and Monitoring drilling fluid parameters
- Strict vigil on pollution.
- Any other chemical related jobs required to maintain trouble free drilling operation.
