candidate should have basic knowledge of Power Amplifiers and Power supply systems along with Computer Hardware, Networking and maintenance of Electronics systems.

Project Engineer on Contract (Mechanical): A First-class Engineering Degree in Mechanical Engineering with minimum 60% marks in aggregate from any recognized institution/ University with three years post qualification experience in the field of Precision mechanical systems related to Reactor Control and preferably experiences on board sub-marines. The candidate should have basic knowledge of Mechanical assembly, Integration and testing of Reactivity Control Mechanisms, Process Sensors etc. He should have good knowledge of engineering drawing.

Asst. Project Engineer on contract [For Post 3& 4]: Engaged initially for a period of One year which may be extended upto maximum of four years (including initial period) based on requirement and individual performance. Candidates will be paid a consolidated remuneration of Rs. 30,000/-, Rs. 35,000/-, Rs. 40,000/-and Rs. 45,000/- for 1st, 2nd, 3rd and 4th year of contract respectively.

<u>Relaxation of Marks</u>: 1st Class is relaxed to 2nd Class with 50% marks in aggregate for SC candidates.

<u>Age Relaxation</u>: The upper age limit will be relaxed for SC candidates by 5 years and for OBC candidates by 3 years. For candidates belonging to PWD category having minimum 40% disability or more, will get 10 years' relaxation in addition to the relaxation applicable to the categories mentioned above.

The upper age limit is relaxed up to 5 more years proportionately for candidates for post No 3 & 4 who have 5 years or more relevant experience. However, the upper age limit shall not exceed 30 Years for UR Candidates.

The upper age limit is relaxed by 5 years for candidates who had ordinarily been domiciled in the State of Jammu & Kashmir from 01.01.1980 to 31.12.1989.
