- 2. **Experience** –Retired IRSEE Officer with experience in construction/ maintenance of substation, electrical general service and Railway Electrification. The job requirement will include preparation of bids and tenders and execution of projects at various project sites, dealing with various Contractors, Suppliers, local authorities and officials of Clients/Consultants.
- 3. **Duration of the Service Contract** Duration of Service Contract will be initially for a period of 1 year, further extendable till duration of the project or attaining age of 65 years whichever is earlier.
- 4. **Age criteria –** Age should be below 64 years as on the last date of closing of the advertisement.
- 5. **Compensation –** Consolidated lump sum payment per month will be calculated as per formula below: -
- a. Officer retired from CDA Grade = 50% of Last Basic Pay + DA (CDA pattern) there upon as on the date of employment (fixed).
- 6. As part of the recruitment process candidates will have to interact with Interview committee and APAR of last three years will be taken into consideration. All eligible candidates will have to undergo medical test. Vigilance Clearance will also be obtained from the organization from which they retired.
