#### **Essential/Desirable Qualifications:**

Desirable areas of specializations in various departments are given in **Annexure-I** and the vacancy positions in **Annexure-II**. However, candidates with other relevant areas of specializations may also be considered.

All new entrants should have Ph.D. in the relevant / equivalent discipline and should have First Class in the preceding degrees.

In case, first class is not mentioned in the preceding degrees awarded by the University / Institution, then the candidates should have secured at least 6.5 CGPA (on a 10-point scale) or 60% marks in aggregate.

In case the candidate has secured CGPA under any other point scale (other than 10-point scale), then certificate issued by the authorized signatory (not the Mentor/Supervisor/Head of the Department) of the Institute / University to the effect of having secured first class in such degree must be attached. Alternately, the CGPA may be equivalently converted on 10-point scale for determination of eligibility.

### **Preceding Degrees (Basic degrees):**

For faculty positions in Engineering Departments: B.E./B.Tech. or any equivalent degree and M.E./M.Tech. or any equivalent degree in relevant discipline.

Candidates having Ph.D. Degree directly after B.E./B.Tech. from reputed Institutions/Universities will also be considered, if other norms are fulfilled.

For faculty positions in Mathematics: MSc in relevant discipline

For faculty positions in School of Management: MA/MSc/MCom/MBA/MTech in relevant discipline.

### **General Instructions:**

- 1. Faculty positions are currently available in the following teaching departments:

- 2. Detailed Educational Qualifications, Experience and other criteria for selection shall be as per the modified recruitment rules for Faculty in NITs as per schedule E of the first statutes of the NITs (amendment statutes 2017) **Annexure-III.**
- 3. NITK strives to have a workforce which also reflects gender balance and hence women candidates are especially encouraged to apply.
- 4. Besides the basic pay in the applicable pay band of the respective positions, admissible allowances like DA, HRA, etc are payable in accordance with Central Government / Institute Rules in force from time to time.
- 5. The newly recruited faculty are encouraged / supported to take up R&D activities with financial support, like seed grant, and professional development allowance as per Institute norms.
- 6. The applicant will be responsible for the authenticity of submitted information, other documents and photograph. Furnishing any false information and/or suppression/ concealment of facts shall lead to rejection/ cancellation of selection/ recruitment.
- 7. There is no application fee. However, the applicants shall be charged ₹100 as processing fee (non-refundable). Last date for submission of online fee payment is 03.11.2021 till 5:00 p.m.

- 8. Candidates applying for more than one Department are required to submit separate application forms.
- 9. Reservation and Concession as per GoI norms. Candidates belonging to SC/ST/OBC(NCL) categories should attach certificate obtained from Revenue Authorities not below the rank of Tahasildar or from a First-Class magistrate of the place of domicile of the candidates clearly authenticating the category to which they belong. Applicant belonging to OBC category but coming in creamy layer will not be entitled for the benefit of reservation. In case of OBC-NCL category candidates, latest non-creamy layer certificate is essential (issued on or after 01.04.2021).
- 10. Reservation for PwD will be as per Govt. of India norms. The persons with disability (PWD) shall be required to submit the medical certificate in the prescribed form issued by the competent authorities for the purpose of employment as per GOI norms along with their application. Persons suffering from not less than 40% of the disability shall only be eligible for the benefit of reservation.
- 11. Transgender candidates are required to upload/attach certificate/identity proof issued by Govt./ competent authority.
- 12. Any application without copy (self -attested) of all relevant certificates/ testimonials is liable to be rejected.
- 13. Incomplete applications and applications not received within the due date shall be summarily rejected.
- 14. Candidates with Ph.D. from NITK can apply only after having at least 3 years Post-Doctoral experience outside NITK. However, this is not applicable to the candidates who are already faculty members of NITK.
- 15. Clarifications pertaining to Recruitment Rules by MoE vide F.No.33-9/2011-TS.III, dated 30.11.2017, 04.12.2017, 31.01.2018 and 16.04.2019 shall be considered wherever applicable. (Annexure-IV to Annexure VII).
- 16. Mere fulfilment of the required qualifications and experience, does not entitle a candidate to be called for interview / selection. Different Departments may set different shortlisting criteria.
- 17. The Institute reserves the right to fill or not fill any of the positions. The number of positions may also vary as per the need of the Institute at the time of recruitment.
- 18. The Screening committee shall shortlist the eligible and most desirable candidates to be called for interview from amongst the applicants, based on specialization, availability of candidates, and requirements of the departments. In doing so it shall not be bound by the options exercised by the applicants.
- 19. The Institute reserves the right to restrict the number of candidates for interview to a reasonable limit, on the basis of qualifications and experience higher than those prescribed in this advertisement.
- 20. All Degree Certificates should be from recognized Universities / Institutes.

- 21. Candidates in service (Govt. / Quasi Govt. / PSUs / State or Central Universities / Educational Institutions) should send their applications through proper channel and should furnish a "**No Objection Certificate**" from the Competent Authority of the serving organization.
- 22. All original documents including valid ID Proof will have to be produced at the time of presentation and/or interview for verification; otherwise, they may not be allowed to appear for the presentation and/or interview.
- 23.SC / ST/ PwD candidates called for Interview shall be reimbursed as per Govt. of India norms for the to and fro journey by the shortest route from their correspondence address / working Place in India subject to production of ticket(s) & proof of working/ residence in case they are travelling from the place of working in India and self attested documents in support of eligibility.
- 24. Selected candidates should be prepared to join duty within the time granted.
- 25. Interview call letters to eligible candidates will be issued to their E-Mail ID only. List of eligible candidates called for written test and /or Interview will be uploaded in the Institute website. No separate letter (Hard copy) will be sent for this purpose. Further, for any updates, subsequent amendments in the advertisement and results, please visit the Institute website regularly.
- 26. The candidate is responsible for the correctness of the information provided in the application. If it is found, at a later date, that any information given in the application is incorrect / false, the candidature / appointment is liable to be cancelled / terminated.
